

CLUB LICENSING CATALOGUE OF SANCTIONS

Edition 2025

SECTION ONE: GENERAL PROVISIONS

- 1. The implementation of the Club Licensing process must be respected by all FERWAFA members and regional associations. The FERWAFA Club Licensing Regulations stipulates that FERWAFA shall implement a catalogue of sanctions and carry out spot-checks with the Licensees (clubs) to ensure that the licenses are properly awarded.
- 2. In order to guarantee a competent and fair assessment process, FERWAFA shall, amongst other things:
 - (a) Set up a schedule of sanctions applicable for the club licensing system, which shall determine necessary corrective measures against the licensee that has violated the Club Licensing Regulations.

- The FERWAFA Club Licensing Catalogue of Sanctions were adopted by the FERWAFA Executive Committee on 19th june 2025 and come into force season 2025/26.

These Sanctions come into force upon being signed as provided below. Unless amended, these regulations shall remain in force.
